Satisfactory trial results (GAR 77):-

Stewards spoke to Mr. S. Bye the trainer of Flywheel Alfie regarding the length of time since the greyhound last raced. Flywheel Alfie last raced on 11/05/17. Mr. Bye stated that the greyhound was returning to racing following an injured right back muscle. Pursuant to GAR 77A Flywheel Alfie trialled over 395 metres from box 1, weight 35.6kg, the greyhound was placed first in a field of 4. The time of the trial was 22.98 secs, the greyhound won by a margin of .75 lengths. Flywheel Alfie was cleared.

Satisfactory trial result:-

Special Member trialled over 395 metres from box 8, weight 33.2kg, the greyhound was placed second in a field of 4. The time of the trial was 22.98 secs, the greyhound was beaten by a margin of .75 lengths. Special Member was cleared.
