True Value last raced on 22nd December 2016. Ms. Ivers stated that the greyhound was returning from an extended spell after injury. Pursuant to GAR 77A, True Value trialled over the 425mts from box 2, weight 36.1kg, the greyhound was placed 1st in a field of 4. The time of the trial was 24.58, the greyhound won by a margin of 0.75L. True Value was cleared.
