### MEETING COMMENTS

Satisfactory Trial Results - Dan The Man trialled without blinkers over 400m from box one, weight 31.1kg, the greyhound was placed third in a field of five. The time of the trial was 22.91, the greyhound was beaten by a margin of 1.75L. Dan The Man was cleared to race without blinkers.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Warren Alley, the trainer of Spritely Boy, regarding the length of time since the greyhound last raced. Spritely Boy last raced on 8 January 2017. Mr Alley stated that that the greyhound had been recovering from split webbing and a wrist injury. Pursuant to GAR 77A, Spritely Boy trialled over the 400m from box two, weight 31.8kg, the greyhound was placed fourth in a field of five. The time of the trial was 22.91, the greyhound was beaten by a margin of 2.5L. Spritely Boy was cleared.

Satisfactory Trial Results - Gold Gem trialled over the 400m from box three, weight 25.7kg, the greyhound was placed fifth in a field of five. The time of the trial was 22.91, the greyhound was beaten by a margin of 13.75L. Gold Gem was not cleared.

Satisfactory Trial Results - Seventh Cavalry trialled over the 400m from box four, weight 35.7kg, the greyhound was placed second in a field of five. The time of the trial was 22.91, the greyhound was beaten by a margin of 1.5L. Seventh Cavalry was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Adrian Kenyon, the trainer of Lochinvar Kors, regarding the length of time since the greyhound last raced. Lochinvar Kors last raced on 3 May 2017. Mr Kenyon stated that the greyhound had been recovering from a toe injury.
