Injector was found guilty and suspended for 28 days at Shepparton and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted. Crash Cobra was presented for a re-vet at the conclusion of kennelling and was cleared to race.

#### Satisfactory Trial Results

Crash Cobra trialled over the 390 metre distance from box 1, weight 35.3kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 22.17. The greyhound won by a margin of 14 1/4 lengths. Crash Cobra was cleared.
