Mr McMahon pleaded guilty to the charge, Dr Paula was found guilty and suspended for 28 days at Traralgon and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
