Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. W. McMahon, the trainer of Daffy Duck regarding the length of time since the greyhound last raced. Daffy Duck last raced on 6 February 2017 and is returning to racing following a toe injury. Pursuant to GAR 77A, Daffy Duck trialled over the 315m from box 8, weight,34.2kg the greyhound was placed second in a field of 4. The time of the trial was 18.55 secs, the greyhound was beaten by a margin of 3.5 lengths. Daffy Duck was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. W. McMahon, the trainer of Dr. Harlee regarding the length of time since the greyhound last raced. Dr. Harlee last raced on 12 February 2017 and is returning to racing following a hind leg injury. Pursuant to GAR 77A, Dr. Harlee trialled over the 315m from box 1, weight 25.0kg, the greyhound was placed first in a field of 4. The time of the trial was 18.55 secs, the greyhound by a margin of 3.5 lengths. Dr. Harlee was cleared.
