Ms Rinaldi pleaded guilty to the charge, Destini Ricardo was found guilty and suspended the greyhound for three months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(b), before any future nomination will be accepted.

Stewards spoke to Mr John Higgins, the trainer/handler of the greyhound Free Auto, and reminded him to moderate his communication while boxing a greyhound.
