Meeting Comments:-

Satisfactory Trial Results - Blue Berty trialled over the 425mt from box 3, weight 25.6 kg's, the greyhound was placed 3rd in a field of 4. The time of the trial was 24.17, the greyhound was beaten by a margin of 4L. Blue Berty was cleared. Blue Berty who had previously been approved to race in full blinkers, was cleared to race with a right side only blinker.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. C. Stanton, the trainer of Seabrook Eb regarding the length of time since the greyhound last raced. Seabrook Eb last raced on 4th January 2017. Mr. Stanton stated that the greyhound was returning to race after suffering a fractured shoulder Pursuant to GAR 77A, Seabrook Eb trialled over the 425mt from box 8, weight 27.7 kg's, the greyhound was placed 1st in a field of 4. The time of the trial was 24.17, the greyhound won by a margin of 2L. Seabrook Eb was cleared
