Satisfactory Trial Results - Louie The Lip trialled over the 311mtrs from box 3, weight 28.6kgs, the greyhound was placed 1st in a field of 5. The time of the trial was 17.82, the greyhound won by a margin of 1/2 length. Louie The Lip was Cleared.

Satisfactory Trial Results - Johnny Black trialled over the 311mtrs from box 6, weight 35.3kgs, the greyhound was placed 2nd in a field of 5. The time of the trial was 17.82, the greyhound was beaten by a margin of 1/2 length. Johnny Black was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr G. Howell, the trainer of Spring Rain regarding the length of time since the greyhound last raced.
