Stewards deemed the performance of Magic Maldini unsatisfactory in this event and acting in accordance with GAR 71, Stewards directed that Magic Maldini must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.

Meeting Comments:

Satisfactory Trial Results - Special Member trialled over the 400mtrs from box 8, weight 33.3kgs, the greyhound was placed 2nd in a field of four. The time of the trial was 23.35, the greyhound was beaten by 7.5 lengths. Special Member was Cleared.

Satisfactory Trial Results - Zipping Jake trialled over the 400mtrs from box 2, weight 38.4kgs, the greyhound suffered interference on the first turn and fell. The time of the trial was 23.35. Zipping Jake was Not Cleared.

Zipping Jake was vetted following the trial. It was reported that the greyhound sustained a right hock sprain, a 7 day stand down period was imposed.
