He removed the incorrect greyhound, "Didn't Pay Up". Mr Humphries pleaded guilty, Stewards found Mr Humphries guilty and fined Mr Humphries \$250, wholly suspended for twelve months subject to no further breaches of GAR 86(o).</p>

Satisfactory Trial Results (Blinkers) - Run Tom Run trialled over the 390m from box four, weight 29.9 kgs, the greyhound was placed fourth in a field of four. The time of the trial was 22:58, the greyhound was beaten by a margin of six lengths. Run Tom Run was Cleared To Race In Blinkers.
