The Stewards felt that this incident contributed directly to the actions of Dyna Alice at this stage of the race. In view of this, a charge of failing to chase was not preferred by Stewards and Dyna Alice was placed on a Satisfactory Trial, pursuant to GAR 71.

Libby's Dream was vetted following the event. It was reported that the greyhound sustained an injury to the right monkey, a 14 day stand down period was imposed.

St. Regis was vetted following the event. It was reported that there was no apparent injury found.
