Satisfactory Weight Trial - Jagged Stone trialled over the 400mtrs from box 5, weight 35.0kgs. the greyhound was placed 3rd in a field of 5. The time of the trial was 23.25, the greyhound was beaten by a margin of 2.0 lengths. Jagged Stone was Cleared.

Satisfactory Trial Results - Bless "Em All trialled over the 400mtrs from box 6, weight 29.5kgs, the greyhound was placed 4th in a field of 5. The time of the trial was 23.25, the greyhound was beaten by a margin of 5.25 lengths. Bless "Em All was Cleared.

Satisfactory Trial Results - Supa Shalala trialled over the 400mtrs from box 1, weight 28.8kgs, the greyhound was placed 1st in a field of 5. The time of the trial was 23.25, the greyhound won by a margin of 0.75 lengths. Supa Shalala was Cleared.

Satisfactory Trial Results - Rock Lily trialled over the 400mtrs from box 3, weight 33.2kgs, the greyhound was placed 2nd in a field of 5. The time of the trial was 23.55, the greyhound was beaten by a margin of 0.75 lengths. Rock Lily was Not Cleared.
