Stewards spoke to Mr. R. Cameron, the trainer of the greyhound Antoine. Acting in accordance with GAR 71 (Cramp), Stewards directed that the greyhound must perform a Satisfactory Trial before any future nomination will be accepted.

Mr. Quinn pleaded guilty to the charge, Krazy Jane was found guilty and suspended for 28 days at Healesville and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Satisfactory Trial Results - Aye Milo trialled over the 350m from box 8, weight 35.0kg, the greyhound was placed 4th in a field of 4 starters. The time of the trial was 19.68, the greyhound was beaten by a margin of 12.25 lengths. Aye Milo was not cleared.
