MEETING COMMENTS

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Wayne Vassallo, the handler of Rock Lily, regarding the length of time since the greyhound last raced. Rock Lily last raced on 4 February 2017. Mr Vassallo stated that the greyhound had sustained a right hock injury. Pursuant to GAR 77A, Rock Lily trialled over the 390m from box three, weight 31.9kg, the greyhound was placed first in a field of four. The time of the trial was 22.45, the greyhound won by a margin of 7L. Rock Lily was cleared.

Two Mississippi trialled over the 390m from box one, weight 28.5kg, the greyhound was placed second in a field of four. The time of the trial was 22.45, the greyhound was beaten by a margin of 7L. Two Mississippi was cleared

Jeebus Bird trialled over the 450 m from box one, weight 33.9 kg, the greyhound was placed first in a field of four. The time of the trial was 25.83, the greyhound won by a margin of 6.75 L. Jeebus Bird was cleared.
