Mr. Bettles pleaded guilty to the charge, Sisco Knight was found guilty and suspended for 28 days at Traralgon and it was directed that the greyhound perform a satisfactory trial all tracks pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Meeting comments:-

Satisfactory trial results:-

Megellas Fairy trialled over 395 metres from box 8, weight 31.0kg, the greyhound was placed first in a field of 4. The time of the trial was 22.65 secs, the greyhound won by a margin of 1 length. Megellas Fairy was cleared.

Hurricane Billie trialled over 315 metres from box 1, weight 27.2kg, the greyhound was placed second in a field of 4. The time of the trial was 18.64 secs, the greyhound was beaten by a margin of 3.75 lengths.

Meehan Phil trialled over 315 metres from box 8, weight 34.5kg, the greyhound was placed first in a field of 4. The time of the trial was 18.64 secs, the greyhound won by a margin of 3.75 lengths. Meehan Phil was cleared.

Blackjack Neo trialled over 395 metres from box 1, weight 34.8kg, the greyhound was placed second in a field of 4. The time of the trial was 22.68 secs, the greyhound was beaten by a margin of 1 length. Blackjack Neo was cleared.
