Representative of a greyhound engaged in the event S. Chignell approached Stewards and reported an incident that occurred following the event. As a result of this Stewards spoke to Mrs. C. Abela, Starter Mr. G. Brown and the Steward at the boxes Mr. R. Petterson. Stewards will make further enquiries in due course with all other handlers in the race as all had left the course prior to the inquiry.
	Following the event Stewards established that the greyhound Maximum Babe stayed in the boxes.
	Maximum Babe was vetted following the event. It was reported that there was no apparent injury found.
	Stewards spoke to Mrs. C. Abela the representative of the greyhound Maximum Babe. Stewards deemed that the greyhound Maximum Babe took no competitive part in the event. Under normal circumstances the greyhound would be charged with failing to chase. However, taking into consideration the false start Stewards believe that the charge of an unsatisfactory performance was appropriate and the greyhound will have to undergo a Satisfactory Trial.
