Stewards spoke to Mr. S. Spoljaric the trainer of Punters Paradise regarding the length of time since the greyhound last raced. Punters Paradise last raced on 06/04/17. Mr. Spoljaric stated that the greyhound was returning to racing following a fractured right hind leg and left archillies tendon injury. Pursuant to GAR 77A Punters Paradise trialled over 395 metres from box 8, weight 26.5kg, the greyhound was placed first in a field of 4. The time of the trial was 23.14 secs, the greyhound won by a margin of 3 lengths. Punters Paradise was cleared.
