Spotted Opal last raced on 11 May 2016. Mr Graham stated that the greyhound had changed kennel. Pursuant to GAR 77A, Spotted Opal trialled over the 390m from box five, weight 27.1kg, the greyhound was placed fourth in a field of four.
