After hearing submissions from Mr Graham, the Stewards deemed the performance of Tranquil Flex unsatisfactory and acting in accordance with GAR 71, the Stewards directed that Tranquil Flex must perform a Satisfactory Trial (all tracks) to ensure it's fitness and suitability for racing, before any future nomination will be accepted. Connections further advised that the retirement of Tranquil Flex will now be considered.</p> <p>Stewards charged Handler, Ms Caroline Jones with a breach of GAR 46(2) in that she failed to appear at the kennels by the appointed time to retrieve the greyhound Zipping Monty for racing. Ms. Jones pleaded guilty to the charge and was fined \$100.</p>
