Mrs. Chilcott pleaded guilty to the charge, Rythym Taboo was found guilty and suspended for 3 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b), before any future nomination will be accepted.

Stewards issued a warning to registered person Carol Brinsley after the greyhound Undisputed was late to be retrieved from the kennels prior to the race.
