Supplementary report:-

Mrs. Sultana presented Bandit Brad for a vet check at Warragul (02/01/18) as requested by Stewards. It was reported that there was no apparent injury. At a subsequent inquiry Stewards charged Mrs. Sultana with a breach of GAR 42(2) after she failed to check the clearance to leave course form and gain authorisation from the Stewards prior to removing Bandit Brad from the kennels. Mrs. Sultana pleaded guilty to the charge and was fined the sum of \$100.

Meeting comments:-

Satisfactory trial results:-

Flywheel Alfie trialled over 395 metres from box 1, weight 35.0kg, the greyhound was placed first in a field of 4. The time of the trial was 22.92 secs, the greyhound won by a margin of .25 length. Flywheel Alfie was cleared.

Boom Flash trialled over 395 metres from box 2, weight 33.0kg, the greyhound was placed second in a field of 4. The time of the trial was 22.92 secs, the greyhound was beaten by a margin of .25 length. Boom Flash was cleared.

Lilty Allen trialled over 395 metres from box 7, weight 29.5kg, the greyhound was placed third in a field of 4. The time of the trial was 22.92 secs, the greyhound was beaten by a margin of 1.5 lengths. Lilty Allen was cleared.

Satisfactory and right blinker on trial result:-
