Satisfactory Trial Results - Janray Bandit trialled over the 300m from box two, weight 30.9kg, the greyhound was placed seventh in a field of seven. The time of the trial was 17.16, the greyhound was beaten by a margin of 20L. Janray Bandit was not cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Raymond Matthews, the trainer of Daintree Brave, regarding the length of time since the greyhound last raced. Daintree Brave last raced on 25

January 2017. Mr Matthews stated that the greyhound had been recovering from a broken hock.
