**MEETING COMMENTS**

Satisfactory Trial Results - Quen Bale trialled over the 400m from box one, weight 26.9kg, the greyhound was placed fourth in a field of four. The time of the trial was 23.12, the greyhound was beaten by a margin of 12.5L. Quen Bale was not cleared.

Satisfactory Trial Results - Zipping Nussy trialled over the 400m from box two, weight 27.3kg, the greyhound was placed second in a field of four. The time of the trial was 23.12, the greyhound was beaten by a margin of 0.75L. Zipping Nussy was not cleared.

Satisfactory Trial Results - Inga Ross trialled over the 400m from box six, weight 33.0kg, the greyhound was placed first in a field of four. The time of the trial was 23.12, the greyhound won by a margin of 0.75L. Inga Ross was cleared.

Satisfactory Trial Results - Gregorovitch trialled over the 460m from box one, weight 38.6kg, the greyhound was placed first in a field of four. The time of the trial was 25.83, the greyhound won by a margin of 5.25L. Gregorovitch was cleared.

**SUPPLEMENTARY REPORT**

Licensed Trainer Ms Anita Courts pleaded guilty to a charge pursuant to GAR 86(q). The particulars being that she engaged in conduct that was detrimental and prejudicial to the control of greyhound racing by way of swearing and inappropriate language towards Steward Gary Bromley following the running of race three today. In arriving at penalty Stewards took into account that swearing towards an official or Steward is not acceptable. The need for general and specific deterrence. The incident took place in the kennelling area in front of other licensed participants and Club Staff. The conduct was directed towards a Steward fulfilling his duties which is detrimental to the image and control of greyhound racing. Ms Courts was fined the sum of \$300.
