Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Aaron Blake, the trainer of Kirabilli Dawson regarding the length of time since the greyhound last raced. Kirabilli Dawson last raced on 5 September 2017. Mr Blake stated that the greyhound was returning to racing following a back muscle injury and being seasonal. Pursuant to GAR 77A, Kirabilli Dawson trialed over the 410m from box one, weight 27.0 kgs, the greyhound was placed second in a field of four. The time of the trial was 24:34, the greyhound was beaten by a margin of two lengths. Kirabilli Dawson was Cleared.
