Acting under GAR 69(1) stewards charged Brakae with marring. Mr Willcocks pleaded not guilty to the charge, Brakae was found guilty and suspended for 28 days at Healesville and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.</p> <p>Stewards spoke to Mr Roger Bloomfield, the trainer of the greyhound Roger's Boy, regarding the greyhound's racing manners at the 100m mark. Roger's Boy was vetted following the event. It was reported that the greyhound sustained spike wounds to both hind feet, a three-day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Roger's Boy with failing to pursue the lure with due commitment (by reason of injury). Mr Bloomfield pleaded guilty to the charge, Roger's Boy was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.</p>
