Satisfactory Trial Results - Ancarian Lancer trialled over the 390mts from box 1, weight 28.3kg, the greyhound was placed 6 in a field of 6. The time of the trial was 23.03, the greyhound beaten by a margin of 10L. Ancarian Lancer was cleared.

Satisfactory Trial Results - Mighty Storm trialled over the 390mts from box 2, weight 32.3kg, the greyhound was placed 1 in a field of 6. The time of the trial was 23.03, the greyhound won by a margin of 2L. Mighty Storm was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. D. Boots, the handler of Mako Icon regarding the length of time since the greyhound last raced. Mako Icon last raced on 15th September 2017. Mr. Boots stated that the greyhound was returning to racing from being seasonal. Pursuant to GAR 77A, Mako Icon trialled over the 390mts from box 3, weight 24.9kg, the greyhound was placed 3 in a field of 6. The time of the trial was 23.03, the greyhound beaten by a margin of 3L.
