Satisfactory Trial Results - Mallee Spring trialled over the 315m from box 1, weight 31.3kgs, the greyhound

was placed 1st in a field of 5. The time of the trial was 18.33, the greyhound won by a margin of 2 lengths. Mallee Spring was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. W.McMahon, the trainer of Dr. Condor regarding the length of time since the greyhound last raced. Dr. Condor last raced on 28th April, 2017. Mr. McMahon stated that the greyhound was returning to racing after a spell. Pursuant to GAR 77A, Dr. Condor trialled over the 315m, from box 5, weight 32.8kgs, the greyhound was placed 5th in a field of 5. The time of the trial was 18.33, the greyhound was beaten by a margin of 13.75 lengths. Dr. Condor was Cleared. (Dr. Condor was severely checked on the first turn).
