Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. S. Dervish, the trainer of Pure Eagle regarding the length of time since the greyhound last raced. Pure Eagle last raced on 4th October 2017. Mr. Dervish stated that the greyhound was resuming racing from a right triangle injury.
