Stewards spoke to Mr. Aaron Farley, the trainer of the greyhound Falling In Love regarding the greyhounds racing manners on the home turn. Acting under GAR 69(1) stewards charged Falling In Love with marring. Mr. Farley pleaded not guilty to the charge, Falling In Love was found guilty and suspended for 28 days at Traralgon and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Hurricane Dylan was vetted following the event. It was reported that there was no apparent injury found. Stewards spoke to the trainer, Mr Daniel Despard regarding the greyhound's performance. Mr Despard stated that the greyhound has been trialling satisfactorily at Sale in a half field, however is inexperienced in a full field. Mr Despard further stated that he had not trialled Hurricane Dylan at Traralgon prior to today's event. After considering all evidence, stewards took no further action on this occasion.

Satisfactory Trial Results - Aston Liesel trialled over the 315m from box 7, weight 29.0kgs, the greyhound was placed 2nd in a field of 6. The time of the trial was 18.54, the greyhound was beaten by a margin of a nose. Aston Liesel was Cleared.

Satisfactory Trial Results - Wot Price Boofa trialled over the 315m from box 2, weight 33.9kgs, the greyhound was placed 1st in a field of 6. The time of the trial was 18.54, the greyhound won by a margin of a nose. Wot Price Boofa was Not Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. A. Campbell, the trainer of Cashino regarding the length of time since the greyhound last raced. Cashino last raced on 15th October, 2017. Mr. Campbell stated that the greyhound was returning to racing after a right shoulder injury and a spell. Pursuant to GAR 77A, Cashino trialled over the 315m from box 3, weight 26.0kgs, the greyhound was placed 3rd in a field of 6. The time of the trial was 18.54, the greyhound was beaten by a margin of 4.75 lengths. Cashino was Cleared.

Satisfactory Trial Results - (GAR 77A) - Stewards spoke to Ms. Julie Belsham, the attendant of Blonde Tequila regarding the length of time since the greyhound last raced.
