Mr. Jacobs pleaded guilty to the charge, Mason's Mate was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Stewards issued a warning to Mr. R. Boehm, the trainer of Shotgun Blast regarding the greyhound's racing manners soon after the start.
