Acting under GAR 69(A)(1) stewards charged Atlas Roughead with failing to pursue the lure with due commitment. Mrs. Cookson pleaded not guilty to the charge, Atlas Roughead was found guilty and suspended for 28 days at Shepparton and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Race 12

Meeting Comments:-

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs. P. Boots, the trainer of Fitz Tate regarding the length of time since the greyhound last raced. Fitz Tate last raced on 23rd June 2017. Mrs. Boots stated that the greyhound was returning from a factured left hind leg. Pursuant to GAR 77A, Fitz Tate trialled over the 390mts from box 1, weight 32.9kg, the greyhound was placed 1st in a field of 4. The time of the trial was 22.55, the greyhound won by a margin of 4.75L. Fitz Tate was Cleared.
