Ms. Ivers stated that the greyhound was returning to racing from injury. Pursuant to GAR 77A, Qizzical trialled over the 425mt from box 1, weight 32.6kg, the greyhound was placed 1st in a field of 4. The time of the trial was 24.27, the greyhound won by a margin of 2.5L. Quizzical was cleared.</p> <p>Satisfactory Trial Results - Atlas Roughead trialled over the 425mt from box 3, weight 33.2kg, the</p>
