Our Star, Bushman's Destiny, Ruby's Rosa and Silent Sandy collided soon after the start, checking Ruby's Rosa and Bushman's Destiny. Silent Sandy and Destiny's Child collided at the 300m mark. Banjo's Affair and Nod Ya Head collided approaching the 250m mark.

Stewards spoke with lure driver, Mr. S Courts regarding the placement of the lure soon after the start and reminded him of his responsibilities. After reviewing the race footage, Stewards determined that there was no discernible impact on the outcome of the race.

A sample was taken from Nod Ya Head, the winner of the event.

Wazza Hawk and Lamington Lass collided at the 250m mark. Seaton Star eased on several occasions from the 100m mark to the winning post, colliding several times with Tip Toe Traction. Eaglehawk Miss and Voluptuous Ruby collided at the 100m mark and again at the 50m mark

Seaton Star was vetted and revetted following event eight. It was reported that the greyhound sustained no apparent injury. No veterinary stand down period was imposed. Stewards spoke to Ms Ann Ashworth, the kennel representative for the greyhound Seaton Star, regarding the greyhound's racing manners from the 100m mark to the winning post. Acting under GAR 69(A)(1) stewards charged Seaton Star with failing to pursue the lure with due commitment. Ms Ashworth pleaded guilty to the charge, Seaton Star was found guilty and suspended for 28 days at Healesville and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Ziggy Punter, Trap Queen, Last Outlaw and Sleeping Slick collided soon after the start, checking Trap Queen. Ziggy Punter and Sleeping Slick collided approaching the 250m mark. Cosmic Breeze and Trap Queen collided at the 250m mark, checking Trap Queen. Sleeping Slick checked off Ziggy Punter approaching the 200m mark. Early Storm and Bera Na Liva collided at the 150m mark. 3:02 pm 300m Grade 5 Stewards spoke to Mr Daryl Williams, the trainer of Colluding, regarding the length of time the greyhound has had between races. Collunding last raced on 8 November 2017. Mr Williams stated that the greyhound had sustained a right hock injury. Mr Williams also declared a new weight of 33.7kg for the greyhound in accordance with GAR 39(2). Colluding last raced at 31.9kg.

Stewards spoke to Mr Kevin Chivell, the trainer of Destini Supreme, regarding the length of time the greyhound has had between races. Destini Supreme last raced on 29 October 2017. Mr Chivell stated that the greyhound had sustained injuries to the right hind toes.

Gone Rusty went up with the lids at box rise and was slow to begin.

A sample was taken from White Diamond, the winner of the event.

## MEETING COMMENTS

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Leanne Shingles, the trainer of My Lilly, regarding the length of time since the greyhound last raced. My Lilly last raced on 13 June 2017. Ms Shingles stated that the greyhound had been seasonal and recovering from a stopper injury. Pursuant to GAR 77A, My Lilly trialled over the 300m from box one, weight 29.0kg, the greyhound was placed sixth in a field of six and faltered at the 150m mark. The time of the trial was 17.12, the greyhound was beaten by a margin of 18.5L. My Lilly was not cleared. The greyhound was vetted following the Trial, a ten day stand down period was imposed.

Satisfactory Trial Results - Rhiannon Royale trialled over the 300m from box two, weight 26.9kg, the greyhound was placed fifth in a field of six. The time of the trial was 17.12, the greyhound was beaten by a margin of 8.75L. Rhiannon Royale was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Douglas Burge, the trainer of Taxi, regarding the length of time since the greyhound last raced. Taxi last raced on 28 May 2017. Mr Burge stated that the greyhound had been spelling. Pursuant to GAR 77A, Taxi trialled over the 300m from box three, weight 35.1kg, the greyhound was placed third in a field of six. The time of the trial was 17.12, the greyhound was beaten by a margin of 4.5L. Taxi was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr James Reddoch, the trainer of Dozer Lad, regarding the length of time since the greyhound last raced. Dozer Lad last raced on 25 June 2017. Mr Reddoch stated he had not been training due to illness. Pursuant to GAR 77A, Dozer Lad trialled over the 300m from box four, weight 34.8kg, the greyhound was placed fourth in a field of six. The time of the trial was 17.12, the greyhound was beaten by a margin of 4.75L. Dozer Lad was cleared.

Satisfactory Trial Results - Tiny Octane trialled over the 300m from box five, weight 36.0kg, the greyhound was placed second in a field of six. The time of the trial was 17.12, the greyhound was beaten by a margin of 2L. Tiny Octane was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Gregory Paez, the trainer of Fear Valley, regarding the length of time since the greyhound last raced. Fear Valley last raced on 6 August 2017. Mr Paez stated that the greyhound had a tonsil illness. Pursuant to GAR 77A, Fear Valley trialled over the 300m from box seven, weight 30.7kg, the greyhound was placed first in a field of six. The time of the trial was 17.12, the greyhound won by a margin of 2L. Fear Valley was cleared.
