Race 1

JADE MEDIA PHOTOGRAPHY 2:45 pm 450m Mixed 6/7 In accordance with the GRV Hot Weather Policy, this meeting is marked as 'Hot Weather Affected' due to the forecasted temperature of 34 degrees.

Moonbeam and Damaging Lomar were slow to begin.

Semantic Shift and Run It Straight collided approaching the first turn. Talbragar River checked off Run Ronnie Run approaching the first turn. Damaging Lomar galloped on Raven Joe approaching the first turn. Moonbeam galloped on Run It Straight approaching the first turn. Raven Joe, Moonbeam and Damaging Lomar collided on the first turn, checking all three greyhounds. Run It Straight and Dominant Lomar collided on the first turn, checking both greyhounds. Dominant Lomar checked off Run It Straight on the home turn.

Damaging Lomar was vetted following the event. It was reported that the greyhound sustained a superficial spike wound to the right hind foot. No stand down period was imposed.

SUPPLEMENTARY REPORT

Over the period 13-14 February, the track surface was deep harrowed, re-sanded and the camber was increased by raising the outside 150mm on the top turn - from leaving the back straight to entering the home straight. On Friday 16 February the Club conducted 80 trials and the best times were: 390m 22.20 and 450m 25.54.

No stand down period was imposed. Hodge's Lane was vetted following the event. It was reported that the greyhound sustained an abrasion to the right hind leg. No stand down period was imposed.

Rhomboid raced wide from the first turn to the winning post. Fairytale Ending and Amy Amour collided on the home turn. Fabulous Show and Galloping Benny collided on the home turn.
Restricted Win Heat	Galloping Benny was vetted following the event. It was reported that the greyhound sustained a left flexor tendon injury. A ten-day stand down period was imposed. A pre-race sample was unable to be obtained and subsequently a post race sample was taken from Fairytale Ending, the fourth place-getter in the event.

6:16 pm 390m Restricted Win Heat	Stewards spoke to Ms Tina Womann, trainer of Uni Allen, regarding the length of time the greyhound has had between races. Uni Allen last raced on 15 November 2017. Ms Womann stated that Uni Allen has been recovering from a left front stopper injury.
	A pre-race sample was taken from Lireva.
	Twilight Shae was slow to begin.
	Lireva, Voodoo Hustler and Uni Allen collided approaching the first turn. Rockin' In galloped on Triceps Brachii several times approaching the first turn, causing Triceps Brachii to lose ground And checking Voodoo Hustler. Voodoo Hustler and Uni Allen collided on the home turn. Lireva and Wicked Hillary collided entering the home straight. Voodoo Hustler and Triceps Brachii collided entering the home straight.
	Triceps Brachii was vetted following the event. It was reported that the greyhound sustained an abrasion the left and right hind toes. No stand down period was imposed.
	Wicked Hillary was vetted following the event. It was reported that the greyhound sustained no apparent injury.

Race 12 TOPCAT VIDEO (250+ RANK) VETERANS 6:36 pm 390m S/E Veteran Pingu lost ground soon after the start. She's Vivacious and World's On Fire collided approaching the first turn, checking World's On Fire and Fawn Pursuit. Fawn Pursuit lost ground on the first turn. Paranoia and Fawn Pursuit collided approaching the home turn. Humble Gun and Fawn Pursuit collided in the home straight.

Stewards spoke to Ms Tina Womann, the trainer of Paranoia, and issued a warning to handler (licenced trainer) Mr Steven Collyer, in relation to his failure to remove the greyhound Paranoia from kennels in time to prepare it for racing, pursuant to GAR31.

Stewards spoke to Ms Mandy Shaw, kennel representative for the greyhound Pingu, regarding her failure to present the greyhound for vetting following race twelve. Ms Shaw has undertaken to attend the Ballarat meeting on Monday 19 February 2018 to have the greyhound vetted by the Club Veterinarian. (As per Supp Report BEN 19 February - PINGU vetted at Ballarat 19 February and a 28-day standown for a back muscle injury was reported).

Stewards further spoke to Ms Shaw and issued a warning in relation to her failure to comply with elements of the heat policy as adopted by the controlling body GAR86(ag); and also in relation to removing the greyhounds Pingu and Fawn Pursuit from their allotted kennels without permission of the Stewards GAR 42(2).

Stewards spoke to Mr Colin Newman, the trainer of the greyhound Calen, regarding the greyhound's racing manners approaching the first turn. Calen was vetted following the event. It was reported that the greyhound sustained an abdominal muscle injury, a 14-day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Calen with failing to pursue the lure with due commitment (by reason of injury). Mr Newman pleaded guilty to the charge, Calen was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
