#### Race 1

Elke's Osti was quick to begin

Little Miss Tori, Sweet Emma and Dynamic Ross collided soon after the start, checking Sweet Emma and Dynamic Ross. Mrs. Hardwicke checked off Blackpool Blast approaching the first turn. Little Miss Tori and Dynamic Ross collided on the first turn, checking Dynamic Ross, Mrs. Hardwicke and Last Bandito. Sweet Emma galloped on the heels of Mrs. Hardwicke on the first turn, checking both greyhounds. Dynamic Ross galloped on the heels of Little Miss Tori approaching the home turn, checking both greyhounds. Elke's Osti and Dyna Raze collided several times in the home straight, checking Elke's Osti.

#### Race 2

Jamie's Rocket was a late scratching at 9:17AM due to injury - hamstring soreness (GAR 23). A ten-day stand down period was imposed. Stewards will require a veterinary certificate before any future nomination will be accepted.

Dyna Jenava was guick to begin. Miss Manuka was slow to begin.

Here Comes Tom crossed to the inside soon after the start, checking Regal Memphis. Fabulous Cash and Regal Memphis collided on the first turn, causing Regal Memphis to race wide and collided with Bakali Louis. Fabulous Cash eased approaching the winning post.

Stewards spoke to Mr Jason Formosa, the trainer of the greyhound Fabulous Cash, regarding the greyhound's racing manners approaching the winning post. Fabulous Cash was vetted following the event. It was reported that the greyhound sustained a tarsal sprain to the left hock, a ten-day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Fabulous Cash with failing to pursue the lure with due commitment (by reason of injury). Mr Formosa pleaded guilty to the charge, Fabulous Cash was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

# Race 3

1:07 pm 450m Tier 3 - Grade 7 A pre-race sample was taken from Not Enough Cash.

Runnin' Chapta and Not Enough Cash were slow to begin.

Zuberi crossed to the inside soon after the start, checking Rockin' Joe, La Tiana and Destini Ferrari. Zuberi and Destini Ferrari collided approaching the first turn, checking Destini Ferrari. Stewards spoke to Ms Brooke Berry regarding her difficulty in boxing the greyhound Runnin' Chapta. Stewards directed that Runnin' Chapta be boxed first in future events.

It was reported by the Ballarat Club Veterinarian that the greyhound sustained an injury to the right gracilis (back) muscle and a 28-day stand down period was imposed.
