Race 1

Satisfactory Trial (returning from retirement) - Coby Ago Ago trialled over the 311mtrs from box 1, weight 30.1kgs, the greyhound was placed 6th in a field of 6. The time of the trial was 18.11, the greyhound was beaten by a margin of 23.5 lengths. Coby Ago Ago was Not Cleared.

Satisfactory Trial (GAR 77A) - Stewards spoke to Dean Jeffries, the trainer of Donna O'Muffin regarding the length of time since the greyhound last raced. Donna O'Muffin last raced on 7 August 2017 and is returning after a change of Trainer. Pursuant to GAR 77A, Donna O'Muffin trialled over the 311mtrs from box 2, weight 25.9kgs, the greyhound was placed 5th in a field of 6.
