Acting under GAR 86(o), Stewards charged Mr Dailly with negligently allowing the greyhounds in his care to be kennelled with barking muzzles, which is in breach of the GRV Hot Weather Policy. Mr Dailly pleaded guilty to the charge. When determining the penalty Stewards took into consideration Mr Dailly's co-operation and guilty plea. Mr Dailly was found guilty and a fine of \$200 was issued.

Stewards spoke to Kennel Attendants, Mr T. Varichione, Mr J. Porter and Mr B. Jacuta regarding the above incident and referred them to the Club Manager.
