charge, Starbright Vic was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

MEETING COMMENTS

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Paul Cusack, the trainer of Gin Lee's Pride regarding the length of time since the greyhound last raced. Gin Lee's Pride last raced on 6 August 2017. Mr Cusack stated that the greyhound was returning from a right metacarpal injury and a kennel change. Pursuant to GAR 77A, Gin Lee's Pride trialled over the 390m from box one, weight 32.1kg, the greyhound was placed second in a field of four. The time of the trial was 22.54, the greyhound was beaten by a margin of 2.5L. Gin Lee's Pride was cleared.
