After taking further evidence from trainer Mr Jason Reddoch, Stewards reminded licensed person Kathleen Newport of her responsibilities in that she must seek approval from the trainer before engaging a third party to handle a greyhound without the knowledge of said trainer, pursuant to GAR86(o). Stewards also advised Mr Reddoch that if he has any concerns regarding the handling of his greyhounds, that he report the matter to the Stewards.</p> <p>Satisfactory Trial Results (Blinkers) - Urzael Harbinger trialled over the 300m from box two, weight 25.9kg, the greyhound was placed first in a field of four. The time of the trial was 17.40, the greyhound won by a margin of 1L.
