Lully Singh last raced on 3 December 2017. Mr Mackie stated that the greyhound was returning to racing after being seasonal. Mr Mackie also declared a new weight of 25.0 kgs for Lully Singh in accordance with GAR 39(2). Lully Singh last raced at 26.1 kgs.</p> <p>Bejarano and So It Goes were slow to begin. Stewards spoke to Mr Ian Brown, the handler of the greyhound Knew It, regarding the greyhounds racing manners approaching the home turn. Knew It was vetted following the event. It was reported that the greyhound sustained a right hindleg calf injury, a five day stand down period was imposed. Acting under GAR 69(B)(1), the Stewards charged Knew It with failing to pursue the lure with due commitment (by reason of injury). Mr Brown pleaded not guilty to the charge, Knew It was found guilty and Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
