Meeting Comments:

Satisfactory Trial Results - Mighty Boots trialled over the 425m from box 1, weight 32.7kg, the greyhound was placed 4th in a field of 6 starters. The time of the trial was 24.10, the greyhound was beaten by a margin of 15.75L. Mighty Boots was not cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. B. Lock, the trainer of Borough Black regarding the length of time since the greyhound last raced. Borough Black last raced on 8th September 2017. Mr. Lock stated that the greyhound was returning to racing from being on season and a spell. Pursuant to GAR 77A, Borough Black trialled over the 425m from box 2, weight 27.3kg, the greyhound was placed 3rd in a field of 6. The time of the trial was 24.10, the greyhound was beaten by a margin of 14.5L. Borough Black was cleared.

Satisfactory Trial Results - Sleater trialled over the 425m from box 3, weight 34.8kg, the greyhound was placed 2nd in a field of 6 starters. The time of the trial was 24.10, the greyhound was beaten by a margin of 1L. Sleater was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. J. Caulfield, the trainer of Proud Phoenix regarding the length of time since the greyhound last raced. Proud Phoenix last raced on 6th September 2017. Mr. Caulfield stated that the greyhound was returning to racing from being on season and a spell. Pursuant to GAR 77A, Proud Phoenix trialled over the 425m from box 5, weight 29.4kg, the greyhound was placed 6th in a field of 6. The time of the trial was 24.10, the greyhound was beaten by a margin of 20.75L. Proud Phoenix was cleared.

Satisfactory Trial Results - Mighty Storm trialled over the 425m from box 7, weight 33.3kg, the greyhound was placed 5th in a field of 6 starters. The time of the trial was 24.10, the greyhound was beaten by a margin of 15.5L. Mighty Storm was not cleared.

Satisfactory Trial Results - Amigo Two trialled over the 425m from box 8, weight 30.6kg, the greyhound was placed 1st in a field of 6 starters. The time of the trial was 24.10, the greyhound won by a margin of 1L. Amigo Two was cleared.
