Both starter Mr J. Nicholls and licenced trainer Mr M. Lloyd were given an official caution regarding their behaviour.</p> <p>The Club Veterinary Surgeon examined Fish Armo and no illness was detected. The greyhound was a late scratching at 3.14pm due to weight variation (GAR 39). A 10 day stand down period was imposed. Trainer Mr C. Armstrong was fined the sum of \$100.</p> <p>Mr J. Willoughby, the representative of Daytona Fernando declared a new weight of 27.5kgs for the greyhound in accordance with GAR 39(2). Daytona Fernando last raced at 26.0kgs.</p> <p>Joe Panther, Gunmetal Liam and Mrs. Hardwicke were slow to begin.</p> <p>Speedway Chick checked off Flamin' Miracle soon after the start. Gunmetal Liam and Mrs. Hardwicke collided soon after the start. Daytona Fernando and Flamin' Miracle collided approaching the first turn.
