Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Andrea Dailly, the trainer of Shima Bar, regarding the length of time since the greyhound last raced. Shima Bar last raced on 25th February 2017. Mrs Dailly stated that the greyhound had an extended spell. Pursuant to GAR 77A, Shima Bar trialled over 450m from box one, weight 35.6kg, the greyhound was placed first in a field of four. The time of the trial was 25.24, the greyhound won by a margin of 5.5L. Shima Bar was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Andrea Dailly, the trainer of Flying Flyer, regarding the length of time since the greyhound last raced. Flying Flyer last raced on 28 June 2017. Mrs Dailly stated that the greyhound had an extended spell.
