Acting under GAR 69(B)(1), the stewards charged Jessie Fernando with failing to pursue the lure with due commitment (by reason of injury). B Marshall pleaded guilty to the charge, Jessie Fernando was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

MEETING COMMENTS:

Satisfactory Trial Results - Cosmic Magic trialled over the 311 from box 8, weight 30.7kgs, the greyhound was placed 2nd in a field of 5. The time of the trial was 18.05, the greyhound was beaten by a margin of 3.25 lengths. Cosmic Magic was cleared.

Satisfactory Trial Results - Master Rico trialled over the 311 from box 3, weight 32.3kgs, the greyhound was placed 1st in a field of 5. The time of the trial was 18.05, the greyhound won by a margin of 3.25 lengths. Master Rico was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to S Kipirtisdis, the trainer of Three Fifty One regarding the length of time since the greyhound last raced. Three Fifty One last raced on 9 January 2017. S Kipirtisdis stated that the greyhound was returning from being spelled. Pursuant to GAR 77A, Three Fifty One trialled over the 311m from box 7, weight 33.8kgs, the greyhound was placed 4th in a field of 5. The time of the trial was 18.05, the greyhound was beaten by a margin of 9.25 lengths. Three Fifty One was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to C Goodman, the trainer of Wake Up Wilma regarding the length of time since the greyhound last raced. Wake Up Wilma last raced on 27 August 2017. C Goodman stated that the greyhound was returning from being on season and tonsillitis. Pursuant to GAR 77A, Wake Up Wilma trialled over the 311m from box 6, weight 27.8kgs, the greyhound was placed 3rd in a field of 5. The time of the trial was 18.05, the greyhound was beaten by a margin of 7 legnths. Wake Up Wilma was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to C Goodman, the trainer of Tangoette regarding the length of time since the greyhound last raced. Tangoette last raced on 26 August 2017 (coursing). C Goodman stated that the greyhound was returning from an injured left wrist. Pursuant to GAR 77A, Tangoette trialled over the 311m from box 1, weight 24.9kgs, the greyhound was placed 5th in a field of 5. The time of the trial was 18.05, the greyhound was beaten by a margin of 17.75 lengths. Tangoette was not cleared.
