Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Judy O'Neil, the trainer of Emerley Indigo regarding the length of time since the greyhound last raced. Emerley Indigo last raced on 6 November

2017. Ms O'Neil stated that the greyhound was returning to racing from an extended spell. Pursuant to GAR 77A, Emerley Indigo trialled over the 410m from box two, weight 31.1 kgs, the greyhound was placed fifth in a field of five. The time of the trial was 23:84, the greyhound was beaten by a margin of 8.0 lengths. Emerley Indigo was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Judy O'Neil, the trainer of Emerley Tru Blu regarding the length of time since the greyhound last raced. Emerley Tru Blu last raced on 14 November 2017. Ms O'Neil stated that the greyhound was returning to racing from an extended spell. Pursuant to GAR 77A, Emerley Tru Blu trialled over the 410m from box eight, weight 28.4 kgs, the greyhound was placed third in a field of five. The time of the trial was 23:84, the greyhound was beaten by a margin of 3.25 lengths. Emerley Tru Blu was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Maria Barber, the trainer of Busta Mikado regarding the length of time since the greyhound last raced. Busta Mikado last raced on 22 October 2017. Ms Barber stated that the greyhound was returning to racing from an extended spell. Pursuant to GAR 77A, Busta Mikado trialled over the 410m from box five, weight 34.7 kgs the greyhound was placed first in a field of five. The time of the trial was 23:84, the greyhound won by a margin of 0.25 lengths. Busta Mikado was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Jeff Guy, the trainer of Frac Geek regarding the length of time since the greyhound last raced. Frac Geek last raced on 11 November 2017. Mr Guy stated that the greyhound was returning to racing following a left toe injury. Pursuant to GAR 77A, Frac Geek trialled over the 410m from box six, weight 28.6 kgs, the greyhound was placed fourth in a field of five. The time of the trial was 23:84, the greyhound was beaten by a margin of 7.0 lengths. Frac Geek was Cleared.
