Satisfactory Trial Results - Screaming Oaks trialled over the 400mtrs from box 3, weight 27.3kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 22.90, the greyhound was beaten by a margin of 1/2 length. Screaming Oaks was Cleared.

Satisfactory Trial Results - Kokoda Bobby trialled over the 400mtrs from box 8, weight 30.4kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 22.90, the greyhound won by a margin of 1/2 length. Kokoda Bobby was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs C. McMillian, the trainer of Oh Nikita regarding the length of time since the greyhound last raced. Oh Nikita last raced on 10 September 2017 and is returning from a change of kennels.
