Acting under GAR 69(A)(1) Stewards charged Jagger Moment with failing to pursue the lure with due commitment. Mr Wood pleaded guilty to the charge, Jagger Moment was found guilty and suspended for 28 days at Traralgon and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
