Stewards spoke to Mrs S. Gray, the handler of the greyhound Iceni Menace regarding the greyhounds racing manners in the home straight. Mrs Gray pleaded guilty to the charge, Iceni Menace was found guilty and suspended for 28 days at Ballarat and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
