Kostya Nuffen last raced on 26th July 2017. Mr. Wilson stated that the greyhound was returning from a spell. Pursuant to GAR 77A, Kostya Nuffen trialled over the 390m from box 1, weight 33.7kg, the greyhound was placed 3rd in a field of 5. The time of the trial was 22.58, the greyhound was beaten by a margin of 6L. Kostya Nuffen was Cleared.
